



Certificate of Monitoring for Insurance

Overview

Some insurance companies offer discounts on homeowner's insurance to their customers who have monitoring security service. To see if you qualify for savings on your homeowner's insurance, follow these easy steps:

1. Call your insurance company to see if they offer a discount and, if so, ask what is required in order to qualify.
2. If your insurance company requests proof of monitoring, you can [download a certificate of monitoring](#) (requires login).
3. If your insurance company requires a copy of your billing statement, you can also [download monthly statement](#) on MyADT, once your account has been active for at least 30 days.

NOTE: If an ADT® Authorized Dealer installed the system, you may need to contact the installing Dealer for the certificate.

To obtain a certificate of monitoring, go to **Account > Account Documents > Insurance Certificates** and click on the link below.
